

3.1 Prime Contractor References (L.30.3.3. M.2.3, Req IDs 128, 130, 131, 132, 133)

Every day Level 3 operates and manages the networks that transport the majority of the world's IP traffic and a significant portion of the world's voice traffic. The scale and quality of our operations enable our customers to achieve their telecommunication objectives seamlessly and transparently. Indeed, many of our customers look to Level 3 to serve as their primary vendor in providing IP -related services.

Our expertise in managing large, complex, multi-vendor programs is reflected in the following references (detailed in subsections 3.1.1 to 3.1.4), selected for their relevance to the scope and reach of the WITS 3 contract as described in Section C of the RFP. References provided are capable of documenting the Level 3's performance on similar contracts. These references are from external entities, not affiliates or businesses related to Level 3.

These contracts range in value from \$100 million to nearly \$500 million and are indicative of the trust our customer's place in the quality of our network and services.
