CENTURYLINK WILL NOT BE LIABLE FOR ANY DIRECT, CONSEQUENTIAL, INCIDENTAL, INDIRECT, SPECIAL, PUNITIVE, ANY OTHER DAMAGES FOR ANY CAUSE OF ACTION, WHETHER IN CONTRACT, TORT, OR STRICT LIABILITY RELATED IN ANY WAY TO THE TRANSFER OF ACCOUNT NUMBER LISTED ABOVE OR ANY ACCOMPANYING TELEPHONE NUMBER(S) DESCRIBED IN THIS AGREEMENT, INCLUDING ANY DAMAGES RELATED TO THE TELEPHONE NUMBER FAILING TO BE TRANSFERRED OR ANY LOSSES THAT MAY RESULT TO EITHER PARTY BASED ON INACCURATE OR UNAUTHORIZED INFORMATION

PROVIDED TO CENTURYLINK BY EITHER PARTY. Consequential, incidental, and indirect damages include, but are not limited to, lost profits, lost revenues, and loss of opportunity, whether or not the other party was aware or should have been aware of the possibility of these damages. Each of outgoing subscriber and incoming subscriber will indemnify CenturyLink related to its acts or omissions with respect to any items related to the change of telephone number responsibility described on this form. CenturyLink maintains ownership of all telephone numbers at all times.

**Processing of Form.** This Agreement will not be processed until it is fully completed. Incoming subscriber's billing effective dates will be based on the date this Agreement is processed by CenturyLink and will be communicated to incoming subscriber. Incoming subscriber will pay any applicable service connection charges and activation fees associated with the transfer of the account and telephone number(s). If required according to CenturyLink policies and applicable service terms and conditions, CenturyLink will return applicable deposit amounts to the outgoing subscriber via the method and within the timelines prescribed by those policies and terms and conditions. CenturyLink retains the right to require incoming subscriber to provide deposit amounts required by CenturyLink policies and applicable service terms and conditions, and may obtain such deposits in the manner prescribed by those policies and terms and conditions.
