### CMP Monthly Systems Meeting Wednesday, March 20, 2019

### INTRODUCTIONS AND ANNOUNCEMENTS

Mark Coyne – CenturyLink began by asking if there were any additional participants that had joined the call.

### PRIOR MONTHLY MEETING MINUTES (ATTACHMENT A)

Mark Coyne – CenturyLink asked if there were any comments on the Prior Monthly Meeting Minutes. There were none.

### NEW CRS INITIATED BY CLECS (ATTACHMENT B)

There were no new CRs initiated by CLECs for the March Systems CMP Meeting.

### NEW CRS INITIATED BY CENTURYLINK (ATTACHMENT C)

### SCR022019-1 Rewrite of EASE ASR system documentation

Letty Walker – CenturyLink presented this new CR associated with streamlining the EASE ASR system documentation. She said there were a lot of documents that were somewhat of a carryover from the ASR system consolidation, including UOM Guide, Pre-Order, General Guide, Training guide. Letty said there was no document that is step driven that is in the sequence of EASE processes that she would consider a full User Guide. She said that she has also revamped the Admin Guide to streamline it. Rather than four or five guides, she is planning for two – a User guide and an Admin guide.

Susan Lorence – CenturyLink said we have an Ad hoc meeting tentatively scheduled for Monday, April 1, 2019, from 10 -11 AM MT to review these planned changes. Susan said once we confirm on today's call that no one has any problems with the April 1 date, the Ad hoc meeting notice will be sent. The preliminary documents will be posted to the Web site for customers to be able to review ahead of time.

Kim Isaacs – Allstream asked if these documentation updates will address the content of the custom business rules to become more readable.

Letty Walker – CenturyLink said no, this CR does not address the custom business rules. She said this will make EASE system information easier to find, less redundant and more useable.

Susan Lorence – CenturyLink said we wanted to separate these system documentation updates from the Release system changes so the updates would be clear.

Kim Isaacs – Allstream asked if EASE Web based training was impacted.

Letty Walker – CenturyLink said the Web based training is not impacted. It stands on its own.

### SCR101918-1 Modification of EASE ASR External Apps Menu GUI for Order Status

Mark Coyne – CenturyLink said this CR was implemented March 18, 2019 in conjunction with the EASE ASOG 58 release but the GUI tool associated with this CR has been taken offline due to some issues. An updated Event notice was distributed on Tuesday, March 19, 2019. We will continue to monitor the status of this.

### SCR092618-1IG ASOG 58 – Industry Standard implementation in EASE

Mark Coyne – CenturyLink said this CR was implemented March 18, 2019 with the major EASE ASOG 58 release. The CR is now in CLEC Test. Mark said so far we have not heard of any issues with the release. We will consider moving this CR to a Completed status in the April meeting. Mark asked if there were any questions. ### **Description of Change**

CenturyLink will be introducing a new Application Programming Interface for EASE – ASR. There are no application to application functions that will be changing. This change is only impacting connectivity. The amount of customer impact is dependent on the type of customer connectivity that exists today.

### UPDATE AS OF 09-13-18:

CenturyLink is introducing a change in the EASE UOM gateway that will impact customers utilizing the UOM interface for EASE ASR processing. Customers who ONLY utilize the CenturyLink EASE VFO (GUI) application WILL NOT be impacted by this change. Although we expect minimal impact, CenturyLink will be reaching out directly to the impacted customers to discuss the change needed and set up a timeframe to complete the changes.

CenturyLink will be working with each impacted customer to develop a transition plan and timeline.

Testing could begin as early as 1Q19 with a full implementation in production by November 2019.

### 3/20/19 System CMP Meeting

Mark Coyne – CenturyLink said this CR is associated with the change in the EASE UOM gateway that only impacts customers utilizing the UOM interface for EASE ASR processing. CenturyLink is working directly with the impacted customers to establish a timeline to change to the new API. Mark said the Production effective date is November 2019. We will monitor the CR and keep it in CLEC Test until all customers have been migrated.

### 01/16/19 System CMP Meeting

Mark Coyne – CenturyLink said this CR is now in CLEC test. It will remain in CLEC Test until the full implementation which is planned for November 2019. As a reminder, only EASE UOM customers are impacted by this new API. Mark said CenturyLink SMEs are working with impacted customers to begin testing.

### 12/12/18 System CMP Meeting

Mark Coyne – CenturyLink said the Final Technical Specification System Notice was issued on November 16, 2018. This CR for a new API only impacts EASE UOM customers; it does not impact EASE GUI VFO customers. Testing with impacted customers will begin first quarter 2019 with full implementation in production planned for November 2019. CenturyLink personnel are contacting impacted customers to review the interfaces that will be changing to this new API.

### 11/14/18 System CMP Meeting

Mark Coyne – CenturyLink said the Draft Technical Specification System Notice was issued on October 19, 2018. This new API change only impacts EASE UOM customers; it does not impact EASE GUI VFO customers. Mark said a walkthrough was held on October 30, 2018; no customers called into the call. Testing with impacted customers will begin first quarter 2019 with full implementation in production scheduled for November 2019.

### 10/17/18 System CMP Meeting

Mark Coyne – CenturyLink stated this CR was presented last month associated with the new API that only impacts customers that use the EASE UOM gateway for ASR processing. There are no impacts to customers who only utilize the CenturyLink EASE VFO (GUI) application. The Draft Technical Specification System Notice will be issued on October 19, 2018. The dates in System Notification Timeline are associated with testing with impacted customers. The walkthrough is tentatively scheduled for October 30, 2018. Testing could begin as early as 1Q19 with full implementation in Production planned for November 2019.

NOTE: Attachment I in the System package included a REMINDER that mistakenly referenced IMA customers being impacted by this new API. It is only EASE UOM customers that are impacted.

### 9/19/18 System CMP Meeting

Letty Walker - CenturyLink presented this new CR. She advised that CenturyLink is introducing an upgrade to the EASE UOM gateway API that will only impact customers utilizing the UOM interface for EASE ASR processing. CenturyLink will be reaching out directly to the impacted customers to discuss the change needed and set up a timeframe to complete the changes with each customer. Letty said we could begin testing as early as 1st Quarter 2019 with a full implementation in production by November 2019. It is not a short turnaround. The intent is to provide as much lead time as possible.

Mark Coyne – CenturyLink said we will send a 73 day System notice to relay the app to app changes likely by the end of September. He asked if there were any comments or questions. There were none.

### 3/20/19 System CMP Meeting

Mark Coyne – CenturyLink said this CR was implemented March 18, 2019 in conjunction with the EASE ASOG 58 release but the GUI tool associated with this CR has been taken offline due to some issues. An updated Event notice was distributed on Tuesday, March 19, 2019. We will continue to monitor the status of this.

### 2/20/19 System CMP Meeting

Mark Coyne – CenturyLink said this CR was originally scheduled for the EASE Point Release 5.2 scheduled for implementation January 21, 2019. The CR includes enhancements to the EASE ASR VFO GUI to provide functionality to check on Order status for EASE ASRs throughout their life cycle. Prior to the Point release implementation, the SME team determined additional testing was required and issued an event notification on January 15, 2019 to relay the implementation for this CR would be delayed. The CR is now planned for implementation with the EASE Release 6.0. Information about the CR was included in the EASE GUI Release 6.0 notice that was distributed on February 18, 2019. A Training notice associated with the GUI change will be distributed on Monday, February 25, 2019.

### 01/16/19 System CMP Meeting

Mark Coyne – CenturyLink said this CR is associated with enhancements to the EASE ASR VFO GUI to provide a new tool to check on Order status for ASRs throughout their life cycle. CenturyLink had requested that we include this change in the EASE Release 5.2 that is scheduled for implementation January 21, 2019. That combined initial system release notice was distributed on December 21, 2018. The Final system notice was sent on January 4, 2019. Because CenturyLink is performing some additional testing on the changes associated with this CR, this functionality will not be included in the release that will be effective on January 21, 2019. Mark said on January 15, 2019, an event notification was distributed to relay the delay in implementation.

Susan Lorence – CenturyLink said that Kim Isaacs – Allstream had submitted a question into the CMPCOMM mailbox about that Event notification. Kim had asked if the rest of the EASE ASR Release 5.2 would be delayed. Susan said a response had been sent to relay that the remainder of the release that included the planned Custom Business Rules would go into effect as of January 21, 2019.

### 12/12/18 System CMP Meeting

Mark Coyne – CenturyLink said this new CR was presented last month. The CR is associated with enhancements to the EASE ASR VFO GUI to provide a new tool to check on Order status for EASE ASRs throughout their life cycle. Mark said we discussed last month that we would like to include this GUI update in the EASE Point Release scheduled for implementation for January 21, 2019. We proposed combining the GUI notice and the Custom Business Rules notice for the release into a single notice and comment cycle. There was no disagreement to combine the two notices. The EASE Release 5.2 notice is scheduled for distribution on December 21, 2018.

### 11/14/18 Systems CMP Meeting

Letty Walker – Centurylink presented this new CR to update the EASE ASR VFO GUI. She said there is an option called "External Apps" in EASE today. CenturyLink is adding a new option to that section for Order Status. A customer can use this new tool to check on additional status for EASE ASRs through the ASR life cycle from the time it is accepted to the time it is completed. Letty gave some examples of status that will be available: Status of Build, Ticket number, Project manager assigned, Site survey scheduled date, etc. Letty said CenturyLink would like to include this CR in the EASE ASR Point Release 5.2 which is a Custom Business Rule release. She asked if there were any questions.

Kim Isaacs – Allstream asked if this new option would assist customers in knowing when a site survey is completed vs. having to call CenturyLink.

Letty Walker – Centurylink said yes. She said the tool will allow customers to check for themselves when the survey is scheduled, when it is completed, etc.

Mark Coyne – CenturyLink said we are currently planning to include the CR in the EASE ASR Point Release 5.2 which will become effective on January 21, 2019. He said the CR is intended to provide more information to customers vs. it being a change in process for customers. The Point Release notification has a 30 day lead time with a customer comment cycle. The GUI notification cycle has a 28 day notification lead time also with a comment cycle. Mark said we would like to just send one notice and asked if there were any objections to that approach or if customers preferred two notifications. There were no comments or objections. Mark said there may be some Training information that needs to be updated which will be sent with a 21 day lead time. We will discuss the effective date again in the December CMP monthly meeting.

The EASE Walkthrough began immediately following the monthly CMP meeting for January 2019.

Susan Lorence – CenturyLink referred those on the call to the walkthrough material that was to be reviewed. The CenturyLink Impact Statement for EASE Release 6.0 is posted on the CenturyLink Document review site at http://www.centurylink.com/wholesale/cmp/review.html associated with System notification number SYST.EASE.01.04.19.F.17048.EASE\_ASR\_R6\_DrftTechSpecs.

Letty Walker - CenturyLink conducted the walk-through of the ASOG 58 User Impact Statement associated with the EASE ASR Release 6.0. Letty said the ASOG 58 implementation effective date will be March 16, 2019. During the release implementation, EASE VFO (Virtual Front Office) and UOM (Unified Ordering Model) will be unavailable for processing transactions from 5:00 PM ET on Friday, March 15, 2019 until 7:00 AM ET on Monday, March 18, 2019. Ordering access will be back up at 7:00 AM ET on Monday morning, March 18, 2019. Letty then reviewed the presentation document going through each OBF Issue. Once the Issues to be implemented were reviewed, Letty asked if there were any overall questions. There were none

Letty Walker - CenturyLink then reviewed the table entries with the headings ASR Form, Field, and ASR 58 Modification as listed in the ASOG 58 User Impact Statement.

Kim Isaacs - Allstream asked about address validation associated with CNT - Clarification/Notification Type. Kim asked if a customer submits an address, will CenturyLink as the provider change an address to match the CenturyLink record.

Letty Walker - CenturyLink said the industry allows providers two options to fix an address that does not match. One option is for providers to fix an address on the customer's behalf and send the corrected address back. With the second option, through the use of the CNT field of L and the SUPI field of Y, providers can send the address back and ask customers to submit a supplement to correct it. CenturyLink has chosen the second approach to have customers send in a supplement. Letty said that CenturyLink does not want to auto correct the address and then have it be incorrect and cause problems later. There are a number of new fields listed in the Impact Statement that allow that address to be sent back.

Kim Isaacs - Allstream said she understood and agreed.

Letty Walker - CenturyLink said starting with ASR Form 11, there are a number of new fields that are associated with a new product for Managed Access E-Line but CenturyLink does not have a product to implement at this time. Letty said there is no prohibition to use these fields but CenturyLink will not use the date for anything. She relayed that CenturyLink will communicate in the Final Notice for this release if we are ready to support Latitude and Longitude changes with ASOG 58. Finally, Letty referenced the list of holidays that are included in the document for the coming year.

Susan Lorence – CenturyLink said that Kim had brought up at the last EASE system walkthrough that the holiday list included in the Impact Statement is different what is included in the CenturyLink Customer Contact Business Procedure and the list of recognized holidays in their ICA. Susan said that typically CenturyLink would use an OSS Maintenance notice to identify the additional downtime for a system and asked if it was agreeable for CenturyLink to send such a notice in this instance specific to Legacy Qwest accounts.

Kim Isaacs – Allstream reviewed the wording as listed in their ICA regarding holidays which lists New Years Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.

Susan Lorence - CenturyLink said the three days that were different are Good Friday, the day after Thanksgiving, and Christmas Eve day.

Kim Isaacs – Allstream said that Good Friday is a problem as that is not a holiday for Allstream. Kim said the ICAs should be updated then.

Susan Lorence – CenturyLink said that is a difficult path.

Letty Walker - CenturyLink said we could consider an update to the Holiday table to identify that some portions of CenturyLink will be available on several of the company holidays. For example, we could make a notation that though it is a CenturyLink holiday, CenturyLink will accept orders.

Susan Lorence – CenturyLink said we will come up with some additional information as to how to handle this and we will discuss it in the February meeting since we have some time before the first holiday in April.

Kim Isaacs – Allstream said that would be good.

Susan Lorence - CenturyLink said beside the holiday issue, the other main point that will be captured in the meeting minutes will be the change

associated with address validation. There were no other items identified.

Susan Lorence – CenturyLink relayed the purpose for the Ad Hoc call which was to review the proposed changes to the EASE ASR system documentation associated with CenturyLink Change Request SCR022019-1. The CR was presented in the March CMP monthly meeting by Letty Walker – CenturyLink. Susan said we announced in the meeting that we would be having an Ad hoc call and a meeting notice was sent. The Ad hoc call is associated with planned changes to streamline the current production EASE ASR system documents into two documents: the EASE ASR User Guide and the EASE ASR Admin Guide. The intent is to condense the information into a more useable format. Susan said the agenda will be to review the planned change, answer any questions and confirm the associated deliverables.

Letty Walker – CenturyLink said when we went through the ASR system consolidation, there were a number of system guides that were developed for the consolidation, e.g., EASE ASR Info guide, EASE Implementation Guide, EASR ASR Pre-order guide, etc. Letty said that she thought what would be most beneficial to customers is just two documents: a User Guide and an Admin Guide. She said the Online Training would remain available as it is stand alone.

### EASE ASR User Guide

Letty Walker – CenturyLink said she is putting the ASOG version in the guide. She said that should help identify what is included in the document. Letty then walked through some of the various sections of the EASE ASR User Guide. Some key points included:

- The Table of Contents is interactive so if you click on it, it will take you to that section.
- Document Overview The link to ATIS may change in the future as they are changing their download process.
- Sections/Headings Under a specific Section, the heading will be on the left-hand side with the detailed information provided on the right.
- The Guide has been redesigned to fit the EASE screen layout and is sequenced to match the three main tabs in EASE: Order, Preorder and Template.
- Each tab provides the examples of screen shots to match this section.
- It is more of an intuitive guide that is step driven.
- There is more information than has been available in the past.

Letty asked if it made sense how the guide is now laid out.

Kim Isaacs - Allstream said yes it does.

Letty Walker - CenturyLink said she hoped customers will look through the Guide to determine if they have any questions.

### EASE ASR Admin Guide

Letty Walker – CenturyLink then referred those on the call to the other document available for review and discussion, the EASE ASR Admin Guide. Letty said each company that utilizes EASE has the capability to add, update, remove users through their Admin person. This guide has been redone and is also step-driven to provide more unique information for each company's EASE Admin person. Letty asked if there were any questions about this guide. There were none.

Susan Lorence – CenturyLink asked those on the call to go to the current EASE System page at

https://www.centurylink.com/wholesale/systems/asr.html. She said she wants to review the documents that will be eliminated and replaced with the two documents Letty just reviewed. Under the heading, ASR Guides & Training, the current documents to be removed are:

- · EASE ASR Info Guide
- EASE Implementation Guidelines
- EASE ASR VFO Admin Guide
- EASE ASR VFO User Guide
- EASE ASR Pre-Order Guide
- EASE ASR Training
- EASE GUI Overview
- · EASE Student Guide

Letty Walker – CenturyLink said these documents have all been merged into the EASE ASR User Guide. The two new documents will be available under the ASR Guides & Training.

Kim Isaacs - Allstream asked if the Technical Specifications under the heading ASR Ordering Technical Specifications would be impacted.

Letty Walker - CenturyLink said no, these documents will not be changed.

Kim Isaacs – Allstream asked if CenturyLink would be eliminating the EASE CORA ASR Order Differences that is listed under the FAQ section.

Letty Walker - CenturyLink said yes that will be removed also.

Susan Lorence – CenturyLink then proposed that CenturyLink send a 30 day system courtesy notice that has a timeline that is used for Point release. The notice has a 10 day customer comment review cycle followed 5 days later by a CenturyLink final notice and response to comments if required. Susan asked if that would work for this.

Kim Isaacs – Allstream and Rod Cox – TDS Metrocom both said that would be fine.

Larry Couch – Action Communications said it was fine with them also. They have not been using ASR as frequently.

Susan Lorence – CenturyLink said we will send the system notice out by the end of the week. The meeting minutes will also be distributed as required by CMP. The minutes will be brief covering the main discussion points on the call.

Letty Walker – CenturyLink said she wanted to make sure everyone was aware that in EASE itself, customers can always clink on these guides while they are in the EASE system. The same docs will be available there.

Susan Lorence - CenturyLink asked about the point of when these documents would be updated. Will the expectation be with every release?

Letty Walker – CenturyLink said her view is that these documents will ONLY be changed when there has been a change due to a release or other driver. Otherwise the documents will not be updated with a version number.

Kim Isaacs – Allstream said she tends to agree. Only if there are screen shots or if there is a change associated with the ASOG, then the assumption will be the documents will be updated.

Larry Couch – Action Communications said it was better to keep it simple.

Susan Lorence – CenturyLink said with this in mind, when it is time for an EASE release, if no documentation updates are required, CenturyLink will send a notice identifying that and then will not offer a comment cycle.

Letty Walker – CenturyLink agreed and said she will still create a CMP CR and relay the changes that are included in the release but would not expect a comment cycle if there are no documentation updates.

Susan Lorence - CenturyLink asked if those on the call were all OK with that approach also and if they had any questions.

All those on the call responded with a "yes". No other questions were identified.

Susan Lorence – CenturyLink said she thought that covered everything and thanked those on the call for attending. The Ad hoc meeting was adjourned at 10:30 AM MT.

### 3/20/19 System CMP Meeting

Letty Walker – CenturyLink presented this new CR associated with streamlining the EASE ASR system documentation. She said there were a lot of documents that were somewhat of a carryover from the ASR system consolidation, including UOM Guide, Pre-Order, General Guide, Training guide. Letty said there was no document that is step driven that is in the sequence of EASE processes that she would consider a full User Guide. She said that she has also revamped the Admin Guide to streamline it. Rather than four or five guides, she is planning for two – a User guide and an Admin guide.

Susan Lorence – CenturyLink said we have an Ad hoc meeting tentatively scheduled for Monday, April 1, 2019, from 10 -11 AM MT to review these planned changes. Susan said once we confirm on today's call that no one has any problems with the April 1 date, the Ad hoc meeting notice will be sent. The preliminary documents will be posted to the Web site for customers to be able to review ahead of time.
